

# Guide to Virginia Legal Information Resources

General Legal and Self-Help Titles for the Public and Self-Represented Litigants

## Introduction

Sometimes, people representing themselves in legal matters turn to public libraries to meet their legal information needs. In response, the Virginia Association of Law Libraries Access to Justice Committee\* has compiled a list of legal information resources covering topics as varied as incorporating a business, contesting a traffic ticket, researching health law, obtaining social security, renting a dwelling, buying a house, and writing a will. This list of resources does not constitute legal advice or answers to questions of law. However, this list contains resources for librarians seeking items for their legal collections and independent researchers seeking legal information. While resources that are national in scope are included, the Committee has focused on Virginia legal information. Materials of Virginia Legal Aid, the Virginia Bar Association, the Virginia State Courts, and the Virginia State Bar are featured throughout. Self-help materials published by Nolo Press are heavily represented due to their practical nature and target audience of laypeople. Even still, the Committee recognizes that in some cases, a list of resources, access to an Internet connection, and self-help legal books are not what some library patrons seek. Some library patrons seek legal advice and legal representation which librarians are prohibited from providing. For these patrons, three resources may be useful:

# Forms

There is no uniform "official" set of forms for use in all of Virginia's courts. In addition, any requirements for terms that need to be included, format and appearance of a document filed at a court can vary from one local court to another, so it is very important to advise self-represented litigants to check with the clerk of court in the jurisdiction where the form will be filed to determine their local rules. Many attorneys use a generic form (from a formbook set), check with the clerk of court to determine what local/special requirements are in place for that type of form, and then tailor the generic form for use in that particular locality.

Commercially published sets of formbooks are available at libraries throughout Virginia. One might take a look at the set titled Virginia Forms, published by Lexis/Nexis (<https://worldcat.org/en/title/4307841>) as well as other Virginia-specific legal publications such as *Virginia Family Law: with Forms*, and the series of books published by the Virginia CLE. Many public libraries also provide their patrons online access to Gale Legal Forms Online.
